

# **Privacy Policy**

At Love Pickle Club Pty Ltd (ACN 673 950 340 | ABN 43 673 950 340) ("Love Pickle Club") we are committed to safeguarding your personal information and maintaining your privacy. This Privacy Policy outlines how we collect, use, disclose, and manage your personal data in compliance with the Privacy Act 1988 (Cth) and the Australian Privacy Principles (APPs).

#### 1. Collection of Personal Information

We collect personal information from customers, suppliers, and others with whom we interact to provide our services. This information may include:
